

# 2022 Election Training Sessions - East Bethel

## Election Judge & E-Poll Book Training

Standard training, *required for all judges*. Covers basic information and duties of various service positions on Election Day. Includes overview of the operation and use of the electronic poll book equipment. May be completed in-person at East Bethel City Hall, or online.

## Head Judge Training

Advanced training *required for all City Staff, Assistant Head, and Head Judges*. Covers MN Election Laws, and Administrative- and Human Resource-related election information. Classes provided by Anoka County Elections (ACE) staff. This may include a Post-Primary Debrief session for judges serving in this position at both elections.

## Preliminary Testing

First-round testing of the DS200 (Ballot Counter) and OmniBallot (ADA voting assistance) machines. OmniBallot machines are tested for audio/visual compliance and accuracy by creating test ballots. Test ballots are added to a "Test Deck" of pre-marked ballots issued by the ACE to simulate every possible voting option. Test Deck is used to test setup and compliance on the DS200 machines. This is *strongly recommended* as a way *for new Technology Judges* to become well-versed in working with the in's and out's of the OmniBallot and DS200 equipment.

## Poll Book/Poll Pad Practice

Individual practice session with the equipment that election judges will use to register voters on Election Day. Setting up a practice session is *NOT REQUIRED*. Great chance for any judge to get some hands-on practice.

## Public Accuracy Test

Public Testing session of the voting machines used for vote tabulation in the Primary and General Elections. The public is invited to attend, and election judges are *encouraged to attend*. Attendance is *NOT REQUIRED*. Great chance for judges to become a little more familiar with the ballot boxes/voting machines, before the "big day".

## ONLINE TRAINING

May be completed at the judge's convenience; any time of day or night. Link and login information will be provided to judges who have requested (and been assigned to) online training.

## IN-PERSON TRAINING at CITY HALL

Small group training at City Hall, held in Council Chambers. Groups review the same training material that individuals go through online.
