Budget

The City of East Bethel Budgets for 2011 and 2010 along with 2009 actual amounts are provided on *Page 2* in summary form. Governmental funds, which include General Fund, Special Revenue Funds, Debt Service Funds and Capital Project Funds, are totaled together in this summary. The Water Fund, Sewer Fund, Ice Arena Fund and the Equipment Replacement Fund, which are Proprietary Funds are shown individually.

City Council's review of the 2011 budget began in July and continued into December.

The primary purpose of these meetings are to provide citizens the opportunity to have input and comment on the 2011 budget. The preliminary budget and tax levy was adopted in September and the final budget and levy was adopted on December 1, 2010.

The economy has had a significant impact on

the City including falling property values, reduced state aids and declining development activities. The average residential property in East Bethel lost nearly twelve percent of its value when compared to 2009 values. City

Council and Staff developed plans to balance the budget and minimize impacts on property taxes for 2011 while making provisions for maintaining necessary and essential services.

Sewer and Water Project Given Partial OK

In the fall of 2010, the City of East Bethel bid and awarded projects to provide municipal water and wastewater service in the vicinity of TH 65 and Viking Boulevard. The projects include two wells, a water tower, a water treatment plant, water distribution mains and sanitary sewers. The Metropolitan Council also plans to invest approximately \$24 million in facilities to collect, treat and dispose of the wastewater. The service area of these projects is a 3 mile long by 1.5 mile wide area starting at the south City limits and extending north along TH 65.

In January, 2011, the projects were suspended pending further review. The City Council subsequently hired Robert Schunicht a consulting engineer and part

owner of the firm Landform to complete a review and risk assessment of the projects. The review and risk assessment addresses three key questions:

- 1. Do current demographics support growth and provision of municipal services to this part East Bethel?
- 3. Can East Bethel be competitive with neighboring communities providing municipal services?
- 3. Can the project be funded by growth and not be a liability to existing residents?

The Landform review evaluated the project costs, operation costs, future costs and growth rates to determine if East

Bethel can successfully serve the TH 65/Viking Boulevard project area without financially impacting existing residents. The review presented the following findings:

The overall Metropolitan Area growth patterns and local demographics support continued growth in the TH 65 corridor, however, recent slowing of growth points to a frugal approach to public expenditures.

East Bethel's charges are somewhat higher than its neighboring communities but in an acceptable range.

The Metropolitan Council's \$24 million investment represents 56% of the initial cost of the providing service.

The project bonds have favorable interest rates and save approximately \$2 million in interest costs because of Federal tax credits. Net interest costs over the life of the bonds are \$14.5 million.

Most communities provide basic water treatment initially and do not

add iron and manganese removal treatment until they have a strong customer base.

Delaying the provision of iron and manganese treatment reduces the cost of the initial projects by approximately one-third or \$5 million.

The risk assessment considered three alternatives at the following estimated costs:

Current projects --\$15.4 million Delay iron and manganese removal treatment--\$10.1 to 10.4 million No build--\$5.3 to 9.7 million

The risk assessment concluded that by delaying the water treatment plant new customers can financially support the system at a much reduced rate of growth. The review and risk assessment recommends proceeding with the 65/Viking projects without the iron and manganese removal plant.

The review and risk assessment was presented at a Special City Council meeting on Saturday, February 19. The high cost of the No Build alternative and the resulting potential impact on existing East Bethel residents was a key point in the City Council's discussion. At the end of the lengthy and well attended meeting, the City Council elected to proceed with the projects except the water treatment plant.

The council had learned that most cities in the metropolitan area did not start a water treatment plant at the inception of their water distribution service. However, they all provide basic treatment at the well head.

The council authorized a test well be drilled and water quality samples be collected from the ground water source planned for the new water system. This testing will allow the City to determine whether a water treatment plant as recommended by Bolton and Menk is necessary at this time. The City expects to receive those results in early April.
